## Wedding Photography Agreement/Page 1

This agreement is between Northwestpixel Photographic Services (Photographer), operating in the state of Oregon, and \_\_\_\_\_(Client) of \_\_\_\_\_(State), relating to the clients' wedding that will take place on \_\_\_\_\_(Date) at \_\_\_\_\_(Location). ### Description of Services

Photographer will furnish photographic coverage on the above date. Coverage includes being present at specified time. No later than four weeks after the date of the wedding, the Photographer will deliver to the Clients the contents of the agreed upon package. Albums, prints and enlargements will be ordered separately.

### Exclusivity

The Photographer will be the exclusive photographer hired by the Clients for the purpose of photographing the wedding. Family and friends of the Clients are welcome to photograph the event as long as they will not interfere with the Photographer's duties.

### Prices & Fees

The pricing for this package will be as specified by the 2013 Price List, which includes travel, all coverage, and the delivery of goods.

### Payment

A retaining deposit in the amount of \$500.00 is due and payable at the time the contract for services is signed. This reserves my services for the above mentioned date. The remaining balance is due in full by the event date. Upon signature and receipt of the deposit, Photographer will reserve the date and time agreed upon and will not make other reservations for that date and time. For this reason, the retainer fee of \$500.00 is non-refundable, even if the date is changed or the event is cancelled for any reason.

### Limitation of Liability

While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding, the Photographer's entire liability to the Clients for any claim or loss arising from the Photographer's performance is limited to a refund to the Clients of the amount the Clients paid for services. In the unlikely event of personal illness or other circumstances beyond control of the Photographer, the Photographer will make every effort to find a substitute photographer of equal or greater qualifications, subject to acceptance by the Client prior to the wedding, to fulfill the obligations of this Agreement. If the Client declines the substitute photographer, the Client may instead terminate this Agreement and receive a full refund of all monies paid.

### Terms and Conditions

All Terms and Conditions are understood and agreed upon by the Photographer and the Client.

### Copyright & Usage

Clients will have limited right to make and use copies of the proofs for their own use in e-mail, on personal web pages, and reprints. Clients will not make copies of the images for commercial use. Photographer retains copyright in all images created and will have the right to make reproductions for portfolio samples, self-promotion, and professional competition. Photographer will not make reproductions for other commercial use without first obtaining the written permission of the Client.

### Agreement

This Agreement is not valid until it is signed by the Clients and the Photographer and has been received along with payment of the retainer as specified by the Payment terms, above. This Agreement incorporates the entire understanding between the Clients and the Photographer. Any modifications of this Agreement must be in writing and signed by all parties. Each person signing below will be fully responsible for ensuring that full payment is made according to the terms of this Agreement. The laws of the State of Oregon will govern this Agreement.
